5.3 Advice for firefighters

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Recommended monitoring procedures

SECTION 11: Toxicological information

11.1 Information on toxicological effects
