#### **SECTION 6: Accidental release measures**

### 6.1 Personal precautions, protective equipment and emergency procedures

# **SECTION 8: Exposure controls/personal protection**

Arrange sufficient ventilation by local exhaust ventilation and good general ventilation to keep the airborne concentrations of vapors or dust lowest possible and below their respective threshold limit value. ## Individual protection measures

## 11.1 Information on toxicological effects
