#### **SECTION 4: First aid measures**

#### 4.1 Description of first aid measures

General: In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth

to an unconscious person.

If breathing is irregular, drowsiness, loss of consciousness or cramps: Call 112 and give immediate

treatment (first aid).

Eye contact: Check for and remove any contact lenses. Immediately flush eyes with plenty of water, occasionally

lifting the upper and lower eyelids. In all cases of doubt, or when symptoms persist, seek medical

attention.

Inhalation: Remove to fresh air and keep at rest in a position comfortable for breathing. Give nothing by mouth. If

not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. If unconscious, place in recovery position and get medical attention

immediately.

Skin contact: Remove contaminated clothing and shoes. Wash skin thoroughly with soap and water or use

recognised skin cleanser. Do NOT use solvents or thinners.

Ingestion: If swallowed, seek medical advice immediately and show this container or label. Keep person warm

### 5.2 Special hazards arising from the substance or mixture

Hazards from the substance or

Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. #### 5.3 Advice for firefighters

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Do not release runoff from fire to drains or watercourses. # 6.1 Personal precautions, protective equipment and emergency procedures

# 6.2 Environmental precautions

# **SECTION 7: Handling and storage**

### 7.1 Precautions for safe handling

Vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapors in air and avoid vapor concentrations higher than the occupational exposure limits. In addition, the product should be used only in areas from which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard. To dissipate static electricity during transfer, ground drum and connect to receiving container with bonding strap. No sparking tools should be used.

Avoid inhalation of vapour, dust and spray mist. Avoid contact with skin and eyes. Eating, drinking and smoking should be prohibited in area where this material is handled, stored and processed. Appropriate personal protective equipment: see Section 8. Always keep in containers made from the same material as the original one.

#### 8.2 Exposure controls

#### Appropriate engineering controls

Arrange sufficient ventilation by local exhaust ventilation and good general ventilation to keep the airborne concentrations of vapors or dust lowest possible and below their respective threshold limit value. Ensure that eyewash stations and safety showers are proximal to the work-station location.

#### Individual protection measures

General: Gloves must be worn for all work that may result in soiling. Apron/coveralls/protective clothing must be

worn when soiling is so great that regular work clothes do not adequately protect skin against contact with the product. Safety eyewear should be used when there is a likelihood of exposure.



Hygiene measures: Wash hands, forearms, and face thoroughly after handling compounds and before eating, smoking,

# SECTION 11: Toxicological information

#### 11.1 Information on toxicological effects

Exposure to component solvent vapor concentrations may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system.
